4. Special Courts:-

- In the year 1981, four Exclusive Special Courts were ordered & started functioning from the year 1981 for conducting exclusive trial on the SCs/STs (PoA) Act, 1989 cases in Tiruchirapalli, Thanjavur, Madurai and Tirunelveli.
- Two Exclusive Special Courts were ordered & started functioning from the year 2013 in Villupuram and Sivagangai.
- Four Exclusive Special Courts were ordered & started functioning from the year 2017 in Dindigul, Ramanathapuram, Srivilliputhur and Pudukottai.
- Four Exclusive Special Courts were ordered & started functioning from the year 2018 in Cuddalore, Namakkal, Theni and Thiruvannamalai.
- Three Exclusive Special Courts were ordered & started functioning from the year 2020 in Vellore, Perambalur and Thoothukudi.
- Three Exclusive Special Courts were ordered and stated functioning from the year 2023 in Coimbatore, Salem & Tiruppur District.
- One Exclusive Special Court was ordered and stated functioning from the year 2025 in Kanniyakumari District.

As of now 21 Exclusive Special Court are functional.

- **In the remaining 15 Districts namely Chennai, Tiruvallur, Chengalpattu, Kallakurichi, Ranipet, Thirupathur, Krishnagiri, Dharmapuri, Erode, Nilgiris, Karur, Ariyalur, Nagapattinam, Mayiladuthurai and Tenkasi. The existing Sessions Courts are conducting trial of SCs/STs (PoA) Act, 1989 cases along with other cases**

5. Appointment of Special Public Prosecutor

There are 35 Exclusive Special Public Prosecutors appointed, and are incharge of conducting prosecution for the SCs/STs cases in trial in the Special Courts / Designated Courts of all the Districts / Cities.
